OUR FULL PERPETUAL WARRANTY

DAKOTA GRANITE now certifies that your DAKOTA GRANITE MEMORIAL, made from any of our granite (*Dakota Mahogany®*, *American Rose*, *American Bouquet*, *Bellingham*, *Superior Black*, *Colorado Rose Red*, *Jet Mist*, *American Black*, *Medium Black*, *Blue Pearl*, *Medium Barre*, *Silver Cloud*, or *Morning Rose*) was selected for its natural color and grain and that no artificial or temporary coloring agent or finishing material has been used in the fabrication.

DAKOTA GRANITE will repair or replace, without charge, should the memorial crack, chip, break, discolor, or prove defective in any way attributable to the granite integrity and verified by our inspectors. Such replacement and related costs, including material and shipping, will be borne by DAKOTA GRANITE and its authorized Agent. This warranty does not authorize the party seeking warranty coverage to incur any expense toward replacement or related costs without prior written consent from DAKOTA GRANITE. In the event of a defect in the warranted granite memorial, a claim must be made in writing, including the name of the original purchaser and Dakota Granite order number—mail claims to Dakota Granite, PO Box 1351, Milbank, South Dakota 57252 or contact your sales representative.

DAKOTA GRANITE further warrants that any replacement will be of a color, grain, and grade of granite as close as possible to the original. Since granite is a quarried natural stone, we cannot guarantee that the given color or grain will always be available. While every effort will be made to match the original granite, DAKOTA GRANITE reserves the right to replace the defective portion with granite of a grade, color, or grain marketed by the Company when the warranty is honored; this warranty is subject to inventory and availability of products at the time of claim.

DAKOTA GRANITE will not be responsible for damage from war, theft, vandalism, negligence, unauthorized modification, unusual environmental and atmospheric conditions, acts of God, fire, explosions, floods, or any other natural disaster. This warranty extends to the original purchaser and the purchaser's heirs or assignees. This warranty is valid in perpetuity and becomes effective upon the product's delivery date and or when the terms and conditions of the purchase agreement have been met between the purchaser and the AUTHORIZED DAKOTA GRANITE AGENT.
